Rules for Virtual Office Customers:

1. One month Service Fee Deposit is required for any services.
2. The total volume of your mails and parcel cannot exceed 15 cubic inches. CBC International Group Limited has rights to reject new mails once your total volume exceed 15 cubic inches or the new mail itself exceeds 15 cubic inches.
3. Mails or parcels exceeding 3.5 cubic inches will be kept, at no charge, for 2 working days counting from the day after the parcel is received. We will charge \$20/parcel/day afterwards. In general, we encourage client(s) to pick-up their parcels promptly. We reserve the right refuse to receive or keep it for client(s).
4. Mails and fax will be kept for no more than 30 days. If we have not received any notice from you after 30 days, we will charge a storage charge of \$5/week. If mails are not collected 1 month after we received it, CBC International Group Limited has the right to dispose them at our discretion, without any notice.
5. All Notifications by phone and fax, direct transfer of calls and refax services are restricted to Hong Kong numbers only, unless IDD deposit have been paid. Once the service is terminated, you are not allowed to continue using the telephone and fax number provided by CBC International Group Limited without our authorization or to continue using our address as your registered office address and for any commercial applications. Once founded, we have the rights to claim for damages and compensation from you.
6. Our services do not include any advertising recruitment, product promotion and introduction, placing of orders, estate rent and sale etc.
7. If payment is not settled within 7 days after the due date of service, 5% late charge per week will be added on the total amount for administration fee; if payment is still not yet settled 30 days after the due date of service, CBC International Group Limited has the rights to terminate the service provided without giving any notice at once. You are required to pay HK 500 for the cost associated with the reconnection of services and the overdue charge before the service connection.
8. Early Termination or breach of any rules of the service contract will result in the confiscation of the deposit given.
9. Any request on service termination after the contract service period must be informed to CBC International Group Limited at least 1 month in advance, otherwise the deposit would be confiscated. When we intend to terminate the service after the contract service period, notification must be given to you at least 1 month in advance.
10. It is not allowed to be involved in any fraudulent or unlawful activities at CBC International Group Limited, otherwise we have the rights to cancel all the services provided at once without any objection and any lawsuit is at your responsibility. We are also entitled to forfeit any deposit and reserve the rights to claim for damages and compensation from you. Where any members of the debt collection agency, finance company, police or ICAC require, we have the rights to provide your information/records to them at their request.

虛擬辦公室服務組合細則:

1. 所有服務需繳交 1 個月服務費作為按金。
2. 本中心為閣下接收郵件及包裹之容量為不多於 15 立方呎,一旦郵件總容量超出上限,本中心有權拒絕接收任何新郵件或體積超出 15 立方呎之郵件。
3. 任何體積超於 3.5 立方呎之郵件及包裹,本中心會由收件日起計提供 2 天免費儲存期。之後將收取儲存費用\$20/件/日。一般情況, 我司希望客戶及時取回有關郵件或包裹; 本司保留最終權利拒絕代為收件或保管。
4. 一般郵件及傳真會於本中心存放最多 30 日。如儲存多於 30 日而未有事先通知本中心,本中心會收取該件過期郵件\$5/星期作為儲存費用。如閣下於郵件抵達日起計一個半月內仍未到來領取,本中心有權在不知會閣下之情況下將郵件棄置。
5. 所有電話、電話轉駁、傳真通知及轉發服務, 均只適用於本地號碼。在終止服務後, 貴客戶不能在未經本中心的授權下, 繼續使用以上之商務電話及傳真號碼或繼續使用本中心之公司地址作為公司註冊地址及任何商業用途。若一經發現, 本中心有權向貴客戶追究一切的賠償及損失。
6. 本中心秘書代聽電話服務並不包括廣告招聘, 產品推廣及介紹、落單訂購貨品、地產租售等服務。
7. 如貴客戶未能按時於服務費到期日的七天內繳交服務費, 本中心會額外收取服務費之每星期 5%作行政費用; 逾期交款超過 30 天, 本中心會自動取消貴客戶之服務, 如須重新續用服務, 貴客戶須先繳付港幣 \$ 500.00 作逾期續約手續費及繳交之前所欠之服務費及行政費用。
8. 如貴客戶於合約終止期之前停止服務或違反合約內的任何細則, 所有已繳交之按金將不獲退還。
9. 如貴客戶於合約終止期之前停止服務, 必須給予 1 個月或以上通知期, 否則已繳按金將不獲退還。 如本中心欲於合約終止期後停止貴客戶之服務, 亦須給予 1 個月或以上通知期。
10. 貴客戶不可利用本中心進行任何詐騙及各種不法之活動, 否則本中心有權即時取消貴客戶之所有服務, 不得異議。任何有關之法律訴訟, 均由貴客戶承擔。本中心有權即時沒收已繳按金, 並保留向貴客戶追討任何損失及賠償。若遇有收數公司、財務公司、警務人員及廉政公署調查員查詢貴客戶資料時, 本中心有權將貴客戶之資料提供給前述人仕。
